Candidates are requested to bring all the original certificates/ documents along with **02 ( two )** sets of clear & legible self-attested photocopies each of the original certificates/ documents as per para 17.4 of CEN No. 01/2019. Further **06 ( six )** passport size latest colour photographs also to be brought at the time of DV. Candidates are to bring **03 ( three )** copies of DV Call letter.
5. Candidates may note that after completion of DV, they will be sent for Medical Examination at the nominated Railway Hospital located in the jurisdiction of RRBs on the next day of DV. Accordingly, candidates have to come prepared for DV and Medical Examination

6. It may be noted that merely calling a candidate for Document Verification does not entitle him/ her in any way to an appointment in the Railways. The candidature of all the candidates is provisional and is liable to be cancelled at any stage of recruitment or thereafter; in case of any discrepancy, inconsistency or deficiency in the document furnished by them or any malpractice on their part at any stage of the recruitment process.
